*Disqualifying felony convictions by category in Alabama as of May 2022*

§ 13A-10-199	Hindrance or obstruction during detection, disarming or destruction of a destructive device
§ 13A-10-200	Possession or distribution of a destructive device or weapon intended to cause injury or destruction
§ 13A-12-191	Dissemination or public display of obscene matter containing visual depiction of a minor
§ 13A-12-231	Trafficking illegal drugs

# ELIGIBLE CONVICTIONS FOR RESTORATION

*Disqualifying felony convictions by category in Alabama as of May 2022*

## Eligible only after pardon

§ 13A-5-40(a)1-19	Murder (Exception: uncommuted death penalty ineligible for restoration)
§ 13A-6-2	Murder (Noncapital, reckless, felony murder, etc.)
§ 13A-6-61	Rape, 1st degree
§ 13A-6-62	Rape, 2nd degree
§ 13A-6-63	Sodomy, 1st degree
§ 13A-6-64	Sodomy, 2nd degree
§ 13A-6-65.1	Sexual torture
§ 13A-6-66	Sexual abuse, 1st degree
§ 13A-6-67	Sexual abuse, 2nd degree
§ 13A-6-69.1	Sexual abuse of a child less than 12 years old
§ 13A-6-69	Enticing a child to enter a vehicle for immoral purposes
§ 13A-6-121	Facilitating solicitation of unlawful sexual conduct with a child
§ 13A-6-122	Electronic solicitation of a child
§ 13A-6-123	Facilitating the online solicitation of a child
§ 13A-6-125	Facilitating the travel of a child for an unlawful sex act
§ 13A-6-124	Traveling to meet a child for an unlawful sex act
§ 13A-10-153	Parents or guardians permitting children to engage in obscene matter
§ 13A-10-154	Possession of obscene matter
§ 13A-10-171	Possession with intent to distribute child pornography
§ 13A-12-192	Possession and possession with intent to disseminate obscene matter containing a minor
§ 13A-12-196	Parents or guardians permitting children to engage in production of obscene matter

## Ineligible for restoration

§ 13A-11-2	Treason
--	Impeachment
--	Murder conviction with uncommuted death penalty
